

OUR MISSION | Texas Advocacy Project's mission is to end dating and domestic violence, sexual assault, and stalking in Texas. Texas Advocacy Project
 empowers survivors through free legal services and access to the justice system, and advances
 prevention through public outreach and education.
 Our vision is that all Texans *live free from abuse.*



Established in 1982 by a group of young lawyers, **Texas Advocacy Project** started as a legal hotline. In the decades since, TAP has evolved into an **expert on legal issues** affecting survivors of powerbased abuse. Today, our **holistic approach** includes both **solutions and prevention**.

Our **solutions** consist of legal and social work services proven to **break the cycle of violence** and get victims to safety. We provide effective services like protective orders, termination of abusers' parental rights, child-custody modifications, as well as assistance with civil issues that affect abuse cases such as housing, employment, education, and financial empowerment. In an effort to advance our vision, **we serve ALL Texans** without regard to socioeconomic status, race, ethnicity, gender, sexual orientation, age, disability, immigration status, or any other distinction.

Our team extends its impact through **prevention** work consisting of a network of **outreach and education** to the public and those that work with survivors including: domestic violence and sexual assault shelters, judges, prosecutors, crime victim services personnel, legal advocates, medical professionals, universities, and students.



The Texas Advocacy Project Fellows Program funds summer law clerks and first year staff attorneys from underrepresented backgrounds to join us in this work.

Most public interest positions for law students are unpaid, which undermines diversity and inclusion efforts. Nowhere is this more dire than in the fight to end gender-based violence! For example, Black women experience intimate partner violence at a rate 35% higher than that of white women; however, they are less likely than white women to use social services or go to the hospital because of domestic violence. **Culturally specific and culturally affirming legal services are essential.**



CHIEF EXECUTIVE OFFICER YEAR IN REVIEW

What. A. Year. Every time I sit down to write this letter, I am truly in awe of what we, together, have accomplished at Texas Advocacy Project. This year is no different! At TAP, our vision is that every Texan live free from abuse; our work this year expands that vision nationwide where, through partnerships, we are laying the foundation for a society that has zero tolerance of abuse of any kind.

Thanks to our incredible staff, Board of Directors, and supporters, TAP has continued to provide legal and social services to victims of domestic and dating violence, sexual assault, stalking, human trafficking, and child abuse **completely free of charge to victims**. In fact, because of this work, over 11,000 more Texans are living in safety!

A highlight of the year was our work on the United States Supreme Court case, U.S. v. Rahimi. The central concern in Rahimi was the fate of a 30-year-old federal law that prohibits the possession of firearms by persons subject to a domestic violence restraining order. Bronwyn Blake, our Chief Legal Officer, along with attorneys at Kelly Hart & Hallman, led a coalition of more than 20 nonprofit agencies in filing an amicus brief in the case urging the Supreme Court to uphold the federal law. Bronwyn and I were honored to have seats in the courtroom to hear the Justices discuss domestic violence and protective orders the tools our lawyers have been employing for decades to protect survivors - and it was encouraging to hear the arguments point towards a (hopefully) favorable outcome. Being the only coalition of direct civil legal service providers presenting a brief, our unique perspective holds pivotal importance in shaping the final judgment in this case.

In 2023, we also expanded the services and awareness work we provide around human trafficking. We began the year by hosting a statewide roundtable discussion at the North Dallas Chamber of Commerce where we engaged the business community to help support survivors of abuse. The Dallas edition of the series highlighted the partnerships between TAP, Health and Human Services, Texas Workforce Commission, and the Dallas Police Department. In September, we hosted the second of our series, focusing on the impact of domestic violence and human trafficking on businesses in the state. We were honored to have First Lady Cecilia Abbott provide the opening remarks.

Our work in serving survivors of human trafficking has gained national attention! I attended the U.S. Chamber of Commerce's Fighting Human Trafficking in the Transportation Sector event in Washington, D.C., and have begun to build relationships with key leaders of the Not on Our Watch organization. I also travelled to Washington, D.C. to participate in a round table discussion with national leaders from the Anti-Human Trafficking Intelligence Initiative (ATII), Homeland Security, and the U.S. Government Accountability Office.

Here are some more highlights from our 41st year:

• The number of people our small but mighty team served is incredible! Our legal team closed over 4,900 cases, bringing over 11,000 victims to safety, while our social workers assisted 1,600 victims. In addition, our Advocacy and Outreach department trained a record 6,500 people!

- TAP's work on the national stage to support survivors in every state has also grown tremendously this year. Our national partnership base for referrals continues to expand, allowing TAP to serve even more survivors.
- Amanda Elkanick Oder, TAP's VP of Advocacy & Outreach, presented at national and international conferences in San Diego, Atlanta, & New Orleans.
- I participated in a panel at the U.S. Chamber of Commerce with experts from the Office of Victims of Crime and University of Maryland to discuss how better to serve survivors through housing and employment issues.
- TAP is now seen as a key expert stakeholder in the work around perinatal maternal health and intimate partner violence, and is recognized as a thought leader by the National Center for Medical-Legal Partnership in this area.
- Our very own Managing Social Worker, Sarah Lackey, was named St. Edward's Social Work Program's Field Instructor of the Year!
- During the 88th Texas Legislative Session, we testified on 17 bills, bringing the voice of our clients to decision-makers.



- One bill in particular. the Natalia Cox Act (SB 1325), will have an immediate bearing on victims. Natalia Cox was a college student at Huston-Tillotson University who was threatened with a gun by an abuser she was dating although she called the police and felt unsafe because he knew where she lived, no one told her that she had a right to terminate her lease. Sadly, just a week later she was murdered. The bill mandated that law enforcement provide notice of these rights to victims, and TAP, in partnership with HHSC and other agencies, created materials that are used today to provide this notice. We are grateful to all of the legislators who worked through session to help the most vulnerable Texans!
- Our HOPE campaigns continue to grow! Our Teen Ambassadors of Hope campaign trained over 100 teens from all across Texas to be leaders in their communities around cultivating healthy relationships. Handbags for Hope sent over 2,987 handbags, diaper bags, and hospital bags to agencies across Texas, and over 1,800 backpacks were sent to 35 agencies across the state during our Backpacks for Hope campaign.
- Finally, our 17th Annual Black & White Ball presented by Accenture was a fabulous success, raising \$1.125 Million! This unrestricted funding is what makes it possible for us to serve every victim who comes to us with no restrictions or qualifiers.

Thank you for joining us in our growth and making this necessary work possible. I am eager to see what we can accomplish together in 2024!



DOMESTIC VIOLENCE

A pattern of behavior in any relationship that is used to gain or maintain power and control over an intimate partner. Abuse can be physical, sexual, emotional, economic, or psychological.



HUMAN TRAFFICKING

The recruitment, transportation, transfer, harboring or receipt of people through force, fraud or deception, with the aim of exploiting them for profit.



DATING VIOLENCE

Violence, abuse, or power and control imbalances that occur in a romantic relationship.



SEXUAL ASSAULT

Actual, threatened, or attempted sexual contact with another person without that person's consent.



CHILD ABUSE

Also called child endangerment or child maltreatment, is physical, sexual, and/or psychological maltreatment or neglect of a child.



STALKING


Actions that make someone feel threatened, oppressed, or intimidated regardless of the relationship.

LEGAL AND SOCIAL WORK SOLUTIONS

OUR SOLUTIONS CONSIST OF LEGAL AND SOCIAL WORK SERVICES PROVEN TO BREAK THE CYCLE OF VIOLENCE AND GET VICTIMS AND SURVIVORS TO SAFETY

SOLUTIONS THROUGH





Texas Advocacy Project's core power is in its legal expertise and experience dealing with power-based abuses. We support our clients primarily through advice and counsel, assistance with protective orders including Magistrate's Order for Emergency Protection (MOEP's), assistance in pro se matters, and direct representation. We also provide assistance with general civil issues that impact power-based abuse cases such as housing, employment, education, and immigration.



Our attorneys work directly with victims in person and utilizing tele-law (the distribution of legal services and information via electronic information and telecommunication technologies). **Tele-law allows long distance client and attorney contact, care, advice, reminders, education, and remote representation.** When rural settings, lack of transport, lack of mobility, or simply the lack of a legal aid office in a county blocks access to the justice system, tele-law bridges that gap.



SPECTRUM OF SERVICES

FLEXIBLE LEVELS OF LEGAL SERVICES TO ENSURE SURVIVORS ARE NOT TURNED AWAY

LEGAL LINE The initial consultation. Free and confidential advice and counsel.

ASSISTED PRO SE

Providing survivors with individualized, unbundled legal assistance, empowering survivors to represent themselves in court.

DIRECT REPRESENTATION

Attorneys stand next to survivors in court proceedings when cases are too complicated to navigate alone and the barriers to justice are too high.

THINKING BIG THROUGH IMPACT LITIGATION

When called for, our attorneys file impact litigation to bring about lasting change beyond one survivor's case. These cases create societal change and ensure future courts serve all survivors fairly. **SPECIALIZING IN LEGAL TOPICS THAT HELP COMBAT POWER-BASED ABUSE.**



LEGAL SOLUTIONS*

PROTECTIVE ORDERS

A court order that prevents an abuser from coming near the survivor, their residence or workplace, and/ or school of a survivor and a survivor's children. If an abuser violates this order, they can be arrested immediately.

CHILD CUSTODY / MODIFICATIONS / ENFORCEMENT / TERMINATION OF PARENTAL RIGHTS / ADOPTION

No longer having to co-parent with an abuser, consult them for important decisions, or worry about who the child would live with in the event of a survivor's untimely death.

TITLE IX ADVOCACY

Legal support provided to a survivor to ensure their school, college, or university properly handles sexual assault or harassment claims, under Title IX.

COERCED DEBT RELIEF

Abusers often use control of finances to force victims to stay in an abusive relationship. In these instances, victims are forced to choose between facing economic hardship or staying with their abuser. Our financial empowerment tools help victims cope with financial abuse.

POST ARREST CRISIS CONSULTATIONS

Collaborating with Austin Police Department, TAP attorneys provide Crisis Consultation Services. Using trauma-informed skills, TAP attorneys contact victims after the arrest of their offender and offer assistance with safety planning and obtaining an Emergency Protective Order (EPO).

DIVORCE

Severing the ties. Permanently and legally separates survivors from their abusive spouses.

TRAUMA-INFORMED TRIAL PREP

A trauma-informed approach begins with understanding the physical, social, and emotional impact of trauma on the survivor. Using a trauma-informed lens, legal and social work staff work with clients to prepare them for the reality of appearing in court. By crafting services and programs that are sensitive and directly responsive to the trauma that many survivors experience after a violent crime, TAP attorneys identify and limit potential triggers to reduce retraumatization and protect their clients' mental and emotional health.

CRIMINAL RECORD RELIEF

TAP attorneys work with survivors of human trafficking and other abuses to expunge criminal records resulting from survivors' victimization. Cleaning a survivor's record is necessary for securing employment, housing, education, and child custody - all critical elements in rebuilding one's freedom and securing sustainable independence. Our social work staff builds on this legal remedy by connecting survivors with the opportunities they are now eligible for.

SOLUTIONS THROUGH

TAP's social workers provide holistic, trauma-responsive care in collaboration with the legal staff. When safety concerns, overwhelming stress, and mental health needs are present, survivors may be unable to fully absorb the advice outlined by the legal staff. Social workers are able to step in and support survivors with these needs. After the successful launch of our Social Work Program in 2021, TAP hired additional social workers to create a strong team of three LMSWs.

TAP'S SOCIAL WORK PROGRAM IMPLEMENTS THE FOLLOWING METHODOLOGY:

STAFF EDUCATION

Each legal workgroup at TAP has a social worker. Embedding social workers in legal teams allows for interdisciplinary collaboration and wraparound services. Social workers help attorneys to see a client as a whole person, with unique and important strengths, protective factors, and needs. Social workers also provide regular professional development trainings for staff, which guide the manner in which staff communicate with survivors and enhance legal outcomes. Trainings have included Social Determinants of Health, High risk factors for lethality, and an introduction to Polyvagal Theory and how it can help staff improve their interactions with survivors.

CRISIS INTERVENTION & PERSONAL SAFETY PLANS

Clients' safety needs are evaluated with Dr. Jacquelyn Campbell's Danger Assessment. **Social workers guide clients to create individualized plans of action to reduce the risks they and their children face.** Safety planning occurs at any stagewhether a client is still with an abuser, is planning to leave an abuser, or has already left. Social workers also assist survivors in processing and understanding the effects of trauma through active listening, psychoeducation, and validation. This is essential, as survivors commonly have a waiting period to access local counseling programs.

EMPOWERMENT COORDINATION

Survivors can be overwhelmed by the amount of agencies reaching out to them and asking them to complete various tasks during one of the hardest times in their lives. Social workers help survivors to understand and navigate the various systems they are intersecting with, such as law enforcement, courts, Office of the Attorney General, and Texas Department of Family and Protective Services. Social workers assist survivors to regain control and autonomy by providing housing, financial, and mental health resources. TAP utilizes community partnerships bv providing warm referrals to external service providers. This means that with a client's consent, we can contact a partner agency on their behalf, lowering the rate of retraumatization in having to tell one's trauma story to multiple agencies.

EDUCATION PARTNERSHIPS

TAP partners with local universities to provide practicum placements (internships) for Bachelor of Social Work and Master of Social Work students. This furthers the reach of our team and provides invaluable experience for the students. These educational partnerships have allowed for innovative virtual programming for TAP clients. TAP Social workers and interns provide accessible workshops and support groups based on the needs of clients. Programming has included a Circle of Security Parenting Support Group and Financial Empowerment Workshops addressing emotions about money after financial abuse, making a budget, and understanding one's credit score. In addition. Social Work interns were pivotal in launching our Client Services Evaluation Program.

JOCELYN'S STORY 2023 COURAGE AWARD HONOREE

Jocelyn met her abuser shortly after beginning college. At the time, she was active in MMA and studying engineering and physics. Her life took an unexpected turn when she broke her leg during a training session. Unable to pursue the things she loved; Jocelyn fell into a depression.

Her abuser relished in her despair, using it as a means to control and manipulate her. Jocelyn believed that marriage might mend the fractures in their relationship, clinging to the hope that things could improve. However, her abuser's violent tendencies only escalated, and the birth of their child marked a traumatic turning point.

During birth, Jocelyn experienced serious medical complications resulting in significant injury. Just two weeks after her son was born her abuser sexually assaulted her in their home. Their disputes grew increasingly physical, prompting Jocelyn to seek a divorce. She consulted a divorce attorney who required a \$6,000 retainer, which felt insurmountable, as Jocelyn's abuser had full control of their finances. Determined to escape the abusive relationship, Jocelyn returned to school to pursue a finance degree, setting her sights on financial independence.

Balancing her studies with motherhood, she fought tirelessly to secure a better future for herself and her son who she feared would one day become his father without intervention. Working long hours at a prestigious accounting firm during busy seasons became her escape from the turmoil at home. When the pandemic forced her to work from home, her situation became untenable. **Fearful that she might become another statistic among murdered abuse victims, Jocelyn decided it was time to take action.** After three years, she established financial independence, secured her own apartment, and returned to MMA to get her fighting spirit back for the divorce proceedings.

Throughout the separation and divorce her abuser continued proceedings. his relentless harassment. Jocelyn realized she would need a protective order from her abuser to find safety for her and her son. After the DA's office refused to help her and her divorce attorney requested another retainer she could not afford, Jocelyn found Texas Advocacy Project (TAP). TAP helped her navigate a grueling legal battle, resulting in a lifetime protective order against her abuser. When her abuser continued to violate the lifetime protective order after the fact, TAP stepped in to enforce the order and keep Jocelyn and her son safe.

Jocelyn and her son are finally free from her abuser. She no longer worries about the influence her abuser will have on her son and is picking back up on the dreams she left behind.

CYNTHIA'S STORY*

Cynthia, mother of three, reached out to TAP's legal line seeking guidance on divorcing her abusive husband, who resides in Mexico. **Enduring emotional abuse, verbal attacks, and infidelity, Cynthia also faced the complexities of international law** governed by treaties like the Hague Convention, which can make divorces complicated and time-consuming. Despite her desire to finally be free from her abuser, Cynthia felt overwhelmed by the prospect of navigating the American legal system as a Spanish speaker.

Encouraged by TAP, she joined our Assisted Pro Se (APS) program, where she received invaluable support from our legal team as Cynthia prepared to represent herself in court. Her first hurdle was serving divorce papers to her abuser overseas. Her TAP attorney's innovative solution, a waiver of service prepared by TAP, streamlined the process and empowered Cynthia to proceed with the case. To ensure she was well prepped for the final hearing, her TAP attorney advised Cynthia on everything including which phone numbers to call for next steps, how to draft emails to court personnel, how to address the judge, and even what to wear for court.

Following tons of preparation and support, Cynthia successfully finalized her divorce after a courageous hearing! Today, Cynthia lives peacefully in safety, caring for her children and mother.

MELODY'S STORY*

Melody is a resilient single mother who faces the daily challenges of providing for her two precious children. Her journey has been marked by immense strength, as she endured harrowing abuse during her pregnancy, an experience her son tragically witnessed. Despite the hurdles, Melody's determination shone through, leading her to secure a lifetime Protective Order after her abuser repeatedly violated her Emergency Protective Order. This vital step has brought safety and peace into her life, shielding her and her children from further terror.

"The lady I spoke with to schedule was very kind, patient, and compassionate. It was very welcomed after repeated "nos" from local attorneys that I have reached out to, as I can't afford even consult fees. I feel hope for the first time in a while regarding legally closing an awful chapter in my life." -TAP CLIENT

LEXI'S STORY*

Lexi and her children have faced unimaginable challenges, enduring the shadow of horrific violence over the past two years, all while courageously evading her abuser. **Thanks to the compassionate support of TAP attorneys, Lexi was able to initiate divorce proceedings without compromising her safety by revealing her location.** Now, she is steadfastly focused on preserving the well-being of herself and her children.

PREVENTION THROUGH POLICY

At Texas Advocacy Project, we know that effective advocacy in the public policy sphere amplifies our capacity to create lasting change for the survivors and communities we serve. By engaging with our democratic process to design practical, constructive policy, we are working towards a reality where all Texans live free from abuse.

The commitment to safeguarding survivors' interests at the Capitol continues yearround. CEO Heather Bellino and VP of Advocacy & Outreach Amanda Elkanick Oder have continued working with key policy entities including the Office of the Attorney General's Human Trafficking Prevention Task Force, the Texas Council on Family Violence's Public Policy Committee, the Texas Association Against Sexual Assault's Policy and Advocacy Team, and Texas Appleseed's Texas Coalition on Coerced Debt.

Thanks to TAP's braided funding stream, we occupy a unique position as the sole legal services provider in Texas capable of advocating for all victims and survivors. In the 88th Texas Legislative Session, organization leaders provided testimonies on 17 bills, effectively channeling the voices of their clients to decision-makers.

In January, Heather participated in the U.S. Chamber of Commerce's Fighting Human Trafficking in the Transportation Sector and round table discussions with leaders from the Anti-Human Trafficking Intelligence Initiative (ATII), Homeland Security, and the U.S. Government Accountability Office in Washington, D.C., underscoring TAP's growing influence and commitment to combating human trafficking at both state and national levels.



A standout moment of the year was our involvement in the United States Supreme Court case, U.S. v. Rahimi. This case scrutinized a federal law prohibiting firearm possession by individuals under domestic violence restraining orders. Led by CLO Bronwyn Blake, in collaboration with attornevs from Kelly Hart & Hallman, TAP spearheaded a coalition comprising over 20 nonprofit organizations. Together, we submitted an amicus brief urging the Supreme Court to uphold the federal law, emphasizing its critical role in safeguarding survivors. Attending the courtroom proceedings was an honor for Bronwyn and Heather, providing insights into the legal discourse around domestic violence issues and the potential positive outcome for victims.

In September, we were honored to convene with **Texas business leaders alongside Texas First Lady Cecilia Abbott** to delve into the significant bills passed during the legislative session and the ongoing efforts to eradicate abuse across the Lone Star State. Through this collaboration, we sought to foster a deeper understanding of the challenges faced by survivors and the role of businesses in creating safer environments for all Texans by staying up to date on the latest policy protections.
